This Privacy Policy describes how Barb Kirkmeyer and The Kirkmeyer for Colorado campaign ("we," "us," or "our") collect, use, and protect information that you provide when visiting our website at **www.kirkmeyerforcolorado.com** (the "Site"). We respect your privacy and are committed to being transparent about our data practices in accordance with applicable federal election laws and privacy regulations.

1. Information We Collect

When you interact with our campaign, you may choose to provide personal information such as your name, email address, phone number, mailing address, employment information (as required for FEC-compliant donations), payment information (processed securely through third-party vendors), or any other information you voluntarily provide.

In addition, when you visit our Site, we may automatically collect certain information about your visit, including your IP address, device information, browser type and operating system, the date, time, and pages viewed, referring and exit pages, and cookie identifiers or similar tracking data. We may also use third-party analytics tools to better understand visitor behavior and improve site performance.

2. How We Use Your Information

We use the information collected to communicate with you about campaign updates, events, and volunteer opportunities. Your information is also used to process and report donations in compliance with FEC requirements, to comply with federal and state laws, to improve our Site and supporter experience, and to protect against unauthorized access, fraud, or misuse. We do not sell or share your personal information for commercial purposes.

3. Donations and Compliance

Colorado state law require that we collect and report certain information for campaign contributions. For any contribution exceeding \$100 in an election cycle, we are required to collect your name, mailing address, occupation, and employer. All contributions are processed through secure third-party payment processors. Contributions must be made from your own funds, and you must be a U.S. citizen or lawful permanent resident and at least 18 years old.

Under Colorado law, contributions from foreign nationals, corporations (except certain small business exceptions), and labor unions are prohibited. Additionally, all contributions are subject to Colorado contribution limits for statewide candidates, and the campaign will report contributions and expenditures in compliance with the Colorado Secretary of State's campaign finance rules.

4. Information Sharing and Disclosure

We may share information with trusted service providers performing functions on our behalf, such as payment processing, email distribution, or website hosting. We may also share information when required by law, including compliance with valid subpoenas or FEC reporting obligations, or to protect our legal rights and prevent misuse of campaign systems. We do not sell personal data to commercial advertisers. Text messaging originator opt-in data and consent will not be shared with any third parties unless required by law.

5. Cookies and Tracking

Our Site uses cookies and similar technologies to enhance your browsing experience and collect usage data. You can manage or disable cookies through your browser settings. Please note that disabling cookies may limit certain website features.

6. Email Communications and Opt-Outs

If you provide your email address, we may send you updates about campaign events, news, or fundraising. You can unsubscribe at any time by clicking the "Unsubscribe" link in our emails or by contacting us directly at **info@kirkmeyerforcolorado**.

7. Data Security

We take reasonable technical and organizational measures to protect your personal information against unauthorized access, loss, or misuse. However, no system is completely secure, and we cannot guarantee absolute security.

8. Links to Other Websites

Our Site may contain links to third-party websites, such as social media platforms or donation processors. We are not responsible for the privacy practices or content of these external sites.

9. Children's Privacy

This Site is not directed to children under 13 years of age, and we do not knowingly collect personal information from minors. If we learn that a child has provided personal information, we will delete it promptly.
